#### **REGULAR SESSION:**

- 1) Approval of Minutes of Previous Meeting (May 11, 2023):

## 2) Treasurer's Report:

- May's revenue is \$5,151.98 (new dues, past due dues, interest, rental, pool key replacements)
- May's expenses were \$7,795.79 (utilities, postage, office supplies, grounds maintenance, association projects, events, pool supplies)
- Year to Date Income \$72,166.21
- Year to Date Expenses \$41,216.06
- Net Income of \$30,950.15
- Total amount in the bank \$178,229.41
- 3.92% interest on \$103,773 on all CDs
- Sent letters to 6 properties with 3 properties reaching out to setup payment plans.
- The lawyer will send letters to 3 properties that are more than 1 year past due.
- Lien letters will be sent to 8 homes that have not paid for 2023. If those homes have not responded by the end of the year the lawyer will send out a letter.
- Adams homes own 10 properties.
- 290 voting memberships
- 5 total payment plans have been established.

# 3) Old Business:

  - 1. Since the pool opened there was a daily average of 8 properties that used the pool with the highest weekend having 23 properties in 1 day.
    - All the duplicate entries were deleted from the report.
- Pool Opening Party
