### Old Business:

Pool closed on September 14th

- Pool maintenance for 2024 \$10,873 and 2025 \$10,244 both years are lower than the past years.
- Pool is winterized
- Lee Pools suggested that we trim some of the pine trees back to help keep the pine needles out
  - Mike has someone that can come out and trim them back for us
- Will make time to put all the tables and chairs in the shed for the winter and will look at them to see if they will last another year
- Total swipes per month
  - June 576 households (60 more than 2024)

  - September 37 households (about the same as 2024)
